



FOD-8 Providing reports for acute and/or common findings of medical imaging studies

Transition to Discipline (TTD) constitutes your PGY1 (13 blocks).
Foundations of Discipline (FOD) constitutes part of your PGY2 (10 blocks).
Residents should aim to log a minimum of 2 EPAs per week.

Criteria:

1. Residents are responsible for completing a minimum of 12 (-twelve) FOD8 EPA's.
2. To be completed by staff radiologists, other faculty members, fellows, or senior residents.

Dimensions:

1. This EPA focuses on the written communication skills of documenting the findings of imaging studies.
2. This includes generating an accurate and concise report, and recommending appropriate management, next steps and/or follow-up.
3. The observation of this EPA is based on the review of a single report, which must be solely the work of the resident.
4. Residents must collect observations from the following:
 - a. At least 5 of each body region (any modality)
 - b. At least 2 abdomen/pelvis CT
 - c. At least 2 chest/cardiac CT
 - d. At least 2 MSK CT
 - e. At least 2 neuro CT
 - f. At least 2 ultrasounds
 - g. At least 5 assessors
 - h. At least 3 staff radiologists
 - i. A variety of diagnoses

Rotations in TTD to Complete this EPA include:

- Introduction to Diagnostic Radiology: Chest Imaging
- Introduction to Diagnostic Radiology: Computed Tomography

Rotations in FOD to Complete this EPA include:

- Ultrasound (2 required)
- Computed Tomography (2 required)
- Chest Imaging (2 required)
- Neuroradiology (2 required)
- Musculoskeletal Imaging (2 required)
- Emergency Trauma Radiology (1 required)
- Breast Imaging
- Vascular and Interventional Radiology
- Gastrointestinal Imaging

- Nuclear Medicine
- Cardiothoracic Imaging

How to Complete an EPA:

1. Login to Elentra, initiate the EPA and provide the assessment demographics. This can be done on your mobile phone or computer.
2. Complete the assessment scale for each dimension.
3. Using the global entrustment scale below, decide whether the resident can be entrusted (Competent and Proficient) overall to perform this activity with a similar case in the future. In general, residents are not expected to be entrustable early in a new stage of training.
4. Discuss feedback and attain coaching tips.
